REGULAR SCHEDULED COUNCIL MEETING
Location: Reidville Presbyterian Church

Mayor Josh Simpson called the council meeting to order at 6:30 p.m. Town Administrator conducted roll call, confirming all council members were present. Pastor Duncan from Reidville Presbyterian delivered the invocation, followed by the council leading the pledge of allegiance.

Action: A motion was made by Bob Jordan, seconded by James Richard, to approve the council minutes from May 13, 2025, as presented. The motion passed unanimously. Councilmember Beardsley confirmed it was the corrected version that is being approved.

Action: A motion was made by Amy Gore, seconded by Bob Jordan, to accept the May 2025 Financial Report as presented. The motion passed unanimously.

Council Member James Richard updated the council on the local government investment pool.

Council Member Bob Jordan informed the council that the HVAC system at 162 Leonard Dr has been repaired. He also reported that a pothole was called in at Arabella Dr and Reidville Rd. After reaching out to SC DOT, he confirmed that they will not be handling the repair, so the town will need to seek bids for the work.

Council Member Amy Gore provided an update on the remaining events for the year, including the upcoming Town Meet & Greet on July 27th and a partnership with Copelands for their back-to-school bash on August 2nd.

Council Member Justin Beardsley informed the council that the town must update its Hazard Mitigation Plan in coordination with Spartanburg County, which will lead the process. Administrator McKaba noted that updating the plan would enable Reidville to apply for FEMA Hazard Mitigation Grant funding in the event of another federal disaster.

Action: A motion was made by Justin Beardsley, seconded by Amy Gore, to renew the Spartanburg County Hazard Mitigation Plan with Spartanburg County. The motion passed unanimously.

Action: At 6:41 p.m. a motion was made by James Richard, seconded by Amy Gore, to enter into an executive session for the announced and posted reasons. The motion passed unanimously.

Action: At 7:51 p.m. a motion was made by Justin Beardsley, seconded by Amy Gore, to come out of executive session and enter into open session. The motion passed unanimously.

Mayor Simpson stated that no decisions were made in executive session only discussions.

Action: A motion was made by Bob Jordan, seconded by Justin Beardsley, to hire Yasmina Meydanova as the Towns 2025 Intern starting Monday June 16, 2025, at the pay rate of \$12.50 per hour. The motion passed unanimously.

Action: At 7:52 p.m. a motion was made by Bob Jordan and seconded by Justin Beardsley to adjourn the meeting. The motion passed unanimously.
